9. Consider awarding the VFW Arena Roof Repair project to GW & Son's Construction for a total cost of \$24,785.00.

10. Consider adopting the Recreation Participation Policy and out of town resident participation request form which will be effective beginning with the 2019-2020 winter activity season.

A MOTION WAS MADE BY COUNCIL MEMBER VETTER, SECONDED BY COUNCIL MEMBER DEMERS, TO ADOPT THE RECREATION PARTICIPATION POLICY AND OUT OF TOWN RESIDENT PARTICIPATION REQUEST FORM WHICH WILL BE EFFECTIVE BEGINNING WITH THE 2019-2020 WINTER ACTIVITY SEASON WITH THE ADDITION UNDER SECTION B, SUBSECTION B, NUMBER 4 PARAGRAPH A TO INCLUDE THE PARK AND RECREATION COMMISSION WILL MAKE A RECOMMENDATION TO THE CITY COUNCIL.

Council Vice-President Grassel said if this is going to be done with the Park and Recreation Commission it will also need to be done with the other boards and commissions and everything will need to come back to the Council. Council member Vetter said everything does come back from the MPO for both councils to vote on, EDA have their own bylaws, and the Park and Recreation Commission's bylaws says it is supposed to make recommendations to the Council. Council Vice-President Grassel said the Commission is supposed to help govern because they had just been handling things within the department before. Discussion followed about how there have been a few requests over the last couple years that have been handled within the department, the commission is there to help advise in these decisions, prior to this the department had made the decision, and in the past there were mixed answers given.

Council member DeMers stated the answers given should be consistent, there could be mixed messages using the commission as a sounding board, and this decision should be made by the office. Mr. Huttunen said the policy and form was developed to be able to answer these kinds of requests and he is okay if they would like to continue with just having the department make the decision if that is what the policy states. Council member DeMers commented how there wasn't much time between registration and the activity starting and asked if there would be enough time to have these requests being reviewed by the commission. Discussion followed about the time frame from receiving these requests and how quickly they would be able to be reviewed. Council President Olstad said the decision needed to be made by Mr. Huttunen and it should not have to come in front of the Council. Mayor Gander stated how the commission has an advisory role, having public input is important, but the decision should be made by the department head. He added this sets the parameters for the future. Mr. Galstad suggested setting up an appeals process.

Council President Olstad asked if there were any other questions on the motion. Council member Vetter stated the wording should be updated and be brought back. Mayor Gander suggested voting on this next week at a special meeting. Council President Olstad said they could hold a special meeting if the wording

could be done before registration starts. Council member Vetter asked if anyone has asked for this. Mr. Huttunen said there was one request which started this process. Council member Vetter stated they should table this item until the following week and withdrew his motion. Council member DeMers said he also withdrew his second to the motion.

11. Consider approving the agreement between the City of East Grand Forks and USA Hockey to adopt comply with the SafeSport Program.

A MOTION WAS MADE BY COUNCIL MEMBER DEMERS, SECONDED BY COUNCIL MEMBER RIOPELLE, TO APPROVE THE AGREEMENT BETWEEN THE CITY OF EAST GRAND FORKS AND USA HOCKEY TO ADOPT COMPLY WITH THE SAFESPORT PROGRAM.

Council President Olstad asked if there were any answers to the questions from the work session. Mr. Huttunen told the Council said he had received some answers but not all. He explained anyone in a leadership role other than coaches need to be listed, they will have to be certified, and the staff would be listed, but the city council did not need to be included on the list. He stated the three staff in the office are already certified and had a background check done so the City complies with the agreement. He added it was suggested to create a committee to help in this process, the chair could be a paid staff person or a volunteer, and the creation of the committee can be discussed at a future work session. He added they have suggested that locker rooms be monitored by coaches or team managers since they already have a background check and are certified. He said starting next year the background checks will be a cost to the City at \$30 per person.

A MOTION WAS MADE BY COUNCIL MEMBER DEMERS, SECONDED BY COUNCIL MEMBER HELMS, TO ADOPT THE EAST GRAND FORKS LOCKER ROOM POLICY AND THE YOUTH HOCKEY POLICY AND GUIDELINES FOR LOCKER ROOM USE FOR COMPLIANCE WITH THE SAFESPORT PROGRAM.

Council member Vetter asked if this was specific to hockey and if there was going to be a different one for each sport. Mr. Huttunen said this was specific to hockey from USA Hockey, there is a part that is specific to the City, and they are talking with figuring skating group to come up with a policy for the locker room, and the SafeSport policy is different for figure skating compared to hockey. He continued saying how the summer sports do not have a US governing body but staff is starting to talk about how this will be developed for all of the sports.

COUNCIL/STAFF REPORTS:

Mayor Gander updated the Council on the governor's fishing opener, it is being coordinated by the Convention and Visitors Bureau, the application is due in November of this year to host the opener on May 15, 2021, events will start on May 13th, businesses are being notified, and they are starting a social media campaign for this. He added the City is not a shoe-in for this event and there will be about six cities competing for this.

Mayor Gander stated Heritage Days was a huge success, the parade was well attended, and thanked police, fire, and all others who helped make the route possible. He said the hotdish contest was great with 16 kinds of hotdishes that were entered, and he would leave the rest to Council member Helms to talk about. He ended by saying that Rockin Up North Fest was another example of a great event that can happen, he thanked the organizers of that event, there was great attendance for this event, and he thanked staff for helping with the coordinating of permits and road closures for this event. He added he hoped to see more events like this in the future.

Council Member Helms thanked the Mayor and Council members Olstad and Riopelle, Mr. Murphy, and Mr. Gorte for helping out in the burger stand over the weekend. He said it went so well they had to shut down early because they ran out of food. He said it was the first time he had participated in the hotdish contest and the judges had a great time participating. He thanked the fire and police department for helping out with the parade.

Council Member Riopelle thanked Chief Hedlund for cleaning up his parking lot and they appreciate him going out and doing this on his own time.

Council Member Johnson said it was nice to see the scouts attending the meeting.

Mr. Murphy said Heritage Days was very good success for his father-in-law because he was able to see the Canadian version of the Oliver tractor for the first time ever.
