Checklist for Application

- A copy of the dated invoice
- Completed Application
- **"ENERGY STAR STICKER"** for proof of **Energy Star Northern Region** qualified windows & doors
- Building Inspector signed after inspection

This program is available to all multi unit owners where the building to be weatherized receives electric service from the East Grand Forks Water and Light Department.

General Qualifications

- Submit a written proposal of your project to the Department for review & approval before project is started. The proposal should include:
 - An explanation of the weatherization measures to be completed
 - Which apartment numbers will be involved in the project
 - Project costs
- A building permit must be purchased
 - One permit per multi unit building
 - Permit must be purchased before projects starts
 - Project must be completed within 1 year of date of permit
- Project must be completed, and invoice dates must be within the 12 months prior to submitting the rebate application
- Building Inspector must inspect project and sign off on application

Application

- Submit completed application along with copies of dated invoices, building permit & **ENERGY STAR STICKER** showing proof of **Energy Star Northern Region qualified** windows & doors.
- Rebates will be paid in the form of a check to the customer

Inspection and Verification

The Department reserves the right to conduct an inspection of the site after the project is complete to verify that all the program rules and requirements have been met. If the Department finds that the customer has not met its rules and standards, any rebate the customer has received must be returned to the utility.

Rebate Limits

- Rebates are processed on a first come first-serve basis
- Rebate qualifications and amounts are subject to change at any time. East Grand Forks Water and Light Multi Unit Weatherization Rebate Program will stay in place each year unless amended or eliminated.
- The Department will not rebate for the same installation more than once during the expected life of the installation
- The Department reserves the right to limit the maximum amount of rebate per facility/customer in any one year depending on the Department's Conservation Budget.
- The Department does not guarantee that the installation of high-efficiency material or equipment will result in reduced usage or demand or in cost savings.
- The Department makes no warranties, expressed or implied, with respect to any material or equipment purchased and/or installed, including, but not limited to, any warranty of merchantability or fitness for a particular purpose. In no event will the Department be liable for any incidental or consequential damage.
- The Department will not be responsible for any tax liability imposed as a result of the rebate payment. Customers are advised to consult their tax advisor
- The Department is not liable for rebates promised to a customer as a result of a contractor misrepresenting the program.
- *The Department has set a 10 year maximum rebate, when combining all Commercial Rebates, at \$100,000.00 per facility.*
