****MAXIMUM OF ONE WEATHERIZATION REBATE PER HOUSE- HOLD PER 5 YEARS**

Please note: Low to moderate income customers may apply separately through Mahube Community Council for the special low-income energy audit and weatherization program if preferred.

This program rebates **50% of the project cost up to a maximum rebate of \$500** for residential electric customers of the East Grand Forks Water and Light (the Department) to perform energy conservation measures.

General Qualifications

- A building permit must be purchased at the EGF Building Inspector's Office
 - Permit must be purchased before projects starts
 - Permit must be dated no more than 1 year prior to the date the rebate application is turned in.
- Project must be completed and invoice dates must be within the 12 months prior to submitting the rebate application
- If the project is being done on a duplex and owner wants a rebate on both units, 2 building permits will be required. (one for each unit)
- In order to have the labor costs rebated, the project must be completed by a Minnesota Licensed Contractor or a building contractor that is operating under an exemption from the State of MN..
- Building Inspector must inspect project and sign off on application. Call them at 773-2208. **"Please do not return completed forms and necessary documents without the final inspection."**

Acceptable Projects (including, but not limited to)

- Adding insulation to attic (min R-49), walls (min R-19), joists, basements, crawl spaces & adding house wrap or insulation under new siding.
- Caulking & weather stripping
- Replacement of exterior windows & doors (**Energy Star Northern Region qualified**)
 - We do not rebate for egress window installation.
 - We do not rebate for new installations, only replacement of inefficient units.
- Storm door installation (storm doors will not be Energy Star rated)

Application

- Submit completed application along with copies of dated invoices, building permit & **ENERGY STAR STICKER** showing proof of **Energy Star Northern Region qualified** windows & doors. **WINDOWS MUST HAVE U-FACTOR OF .27 OR LESS**
- Rebates under \$200 will be applied to utility bills/over \$200 – will receive a check.

Inspection and Verification

The Department reserves the right to conduct an inspection of the site after the project is complete to verify that all the program rules and requirements have been met. If the Department finds that the customer has not met its rules and standards, any rebate the customer has received must be returned to the utility.

Rebate Limits

- Rebates are processed on a first come first-serve basis
- Rebate qualifications and amounts are subject to change at any time. This Rebate Program will stay in place each year unless amended or eliminated.
- The Department will not rebate for the same installation more than once during the expected life of the installation
- The Department does not guarantee that the installation of high-efficiency material or equipment will result in reduced usage or demand or in cost savings.
- The Department makes no warranties, expressed or implied, with respect to any material or equipment purchased and/or installed, including, but not limited to, any warranty of merchantability or fitness for a particular purpose. In no event will the Department be liable for any incidental or consequential damage.
- The Department is not liable for rebates promised to a customer as a result of a contractor misrepresenting the program.
- The Department may approve or deny any rebate application for reasons that may not be specified in these guidelines.
